COMMITTEE REPORTS

Provided to all Directors in advance and attached to these minutes. The following issues were discussed: Public Art Committee requested that Titus Cartwright be allowed to attend the Trenton United Methodist Church Fine Arts Camp one morning to serve as a mentor to the kids in art class. The board agreed that this would be a good opportunity for the Alliance to serve the community.

OLD BUSINESS

<u>Lunch & Learn.</u> David Carroll, newscaster on WRCB Channel 3, author, and columnist, is confirmed as our speaker for the August 5 Lunch & Learn. Dena Abell will work on menu and room décor. Jane Dixon will talk to the Dade Sentinel about doing a feature in the paper about the event and to the Library and Citizen's Bank about posting the event on their marquees.

<u>Dade Sports Complex Holiday Event</u>. Dena reported that she and Jane have collected and supplied information to the county about possible sources for holiday light displays. The decision is in the county's hands as to whether or not they proceed with the event. The Alliance is happy to help in any way we can, and Dena and Jane will meet with Ted Rumley again for direction.

<u>Light Up Trenton</u>. Jane Dixon moved that the Alliance for Dade fully sponsor the Light Up Trenton event again in 2021. John Rollins seconded the motion, and all Board Directors present approved.

NEW BUSINESS

<u>Dade County Budget Request</u>. George Williams reported that the county has agreed to provide the Alliance with \$10,000 in funding for the July 2021 – June 2022 fiscal year. If county revenue increases, we may receive additional funds. The new Hotel/Motel tax law requiring AirBnB/VRBO/etc. to collect the tax and send it to the county/city should increase our revenue from this source.

GACCE Conference. George and Marcy Williams attended the GACCE conference in Jekyll Island. Key points:

- We made contacts with other chambers and vendors who are very willing to offer help and advice.
- The main presenter, Dr. Melissa Furman, talked about diversity, equity and inclusion and the challenges of managing the different generations of employees Boomers, Gen X, Gen Y and Gen Z.
- All Georgia chambers are dealing with workforce development challenges. They have tried job fairs, student boot camps, and working with local technical colleges. The Alliance can start by creating a task force to meet with the large employers in Dade to ascertain exactly what they need.
- The Knoxville TN Chamber did a presentation about how they re-focused and established a strategic plan concentrating on economic development not events.

<u>RVIC Conference</u>. In order to retain our designation as a certified Regional Visitor Information Center, Titus must attend the annual RVIC conference, which will be held at Lake Lanier August 29-30. Marcy estimates the cost for registration, lodging, meals, and mileage will be ~\$700. Marcy moved that the expense be approved; John Rollins seconded, and all board directors present approved.

<u>Special Events Ordinance</u>. The county is considering an amendment to the existing Special Events Ordinance that would require any event of a certain size to apply for a permit in advance of the event – whether on public OR private property. One of our investors asked the Alliance for its position on this matter. The Alliance will draft a survey to solicit Investors' opinions on this subject and provide the results to the county commissioners.

PUBLIC ART – Sue Gridley

We have taken photos of some available sculptures and plan to add more soon. Titus and I have met to print the photos taken so far of art that could be used in Trenton.

Titus and I also met to go over recommendations for a booklet/slide show of public art (sculpture in this case) displayed in various other communities. William and I met and further refined recommended photos for the booklet/slide show. We have talked with Mark Issenberg, Mr. Sorrell, and I have messaged Isaac Duncan III after seeing his recent installation at Lodge Cast Iron to see what might be available. Mark knows someone else we might be able to contact, and I want to speak with Julie Hailey Clark to get photos of available pieces if there are any.

I also talked with Dottie Abercrombie about the possibility of ways we can participate with her excellent Fine Arts summer program for children at the TUMC. This will start early in July, so we need to get on it if we can be involved. There will be 4 age groups for sculpture, music, drama, and one more.

- Could we display selected works at the office at the end of the program?
- Could we take photos of the music and drama groups?
- Could George do interviews with Dottie and/or the kids for The Alliance website/email posts?
- Would it be OK to ask Titus to take 2 hours one morning from 10-12 to meet with the older kids and their teacher if he says OK?

Finally, could we sponsor a child's attendance for \$50?

I think this has potential for community outreach and getting local families and friends to visit the Alliance office to learn about us, to start referring friends and visitors, to see some of the art, which could be rotated, and to find a reason to join Alliance.

The house Bob Dombrowski lived in is being cleared and some art has been unearthed. I've asked Katie Bien to let me know when any found sculpture might be viewable. It will be available for the public to buy at some point in the future.

We are still working on costs. We think for a temporary installation, depending on the piece, maybe \$400 would be a starting price. But we are exploring things that are less and more costly.

SPORTS COMPLEX CHRISTMAS LIGHT DRIVE-THROUGH – Dena Abell

I sent an email about the idea of a Drive Through Christmas Display at the Sports Complex earlier in the month. This is a follow-up to a meeting that was attended by Stacy Stephens, Ted Rumley, Jane Dixon, Peter Cervelli, and me. Rock City, Event Coordinator, Kyle Kunkill. He was a great help with contacts. Rock City has 5 employees who start after Labor Day, decorating Rock City. Mr. Kunkill has contacts he supplied to me. Vickerman, contact Dinah Jacobs, (352-556-2265). They have two events at the Atlanta Market, January and July. Rock City purchases their lights and other items from this company. Mr. Kunkill inquired if the Sports/Complex had a Business license. Need and account and a minimum dollar order. S4 is their contact for large Christmas items. Ryan Brown 888-660-6640.

AFD is concerned that businesses in Trenton may not want to participate in both "Light up Trenton", and "Christmas Light Display".

County is waiting on approval from GA Power to approve a switch of their grant dollars to Dade County.

The Light Up Trenton committee is Kathleen Reed, Jane Dixon, Dena Abell. We will have another volunteer who will be joining the committee.
