PRESIDENT'S REPORT

Sandy White reported that a consultant from the UGA Small Business Development Center is available to the Alliance and to our investors as a free service.

Welcome Center saw 9 residents, 21 out-of-town visitors and 40 phone calls in the month of November. Sandy has been making visits to existing and potential Investors. She is also making contacts at the state level as she attends meetings.

Dena asked Sandy to contact Bob Venable at Friends of Cloudland Canyon State Park regarding the Run Bum 5K/10K races to see if we can facilitate holding those races elsewhere in the county, as they bring in many visitors.

COMMITTEE REPORTS

DADE EXPO – Jolly Holidays!

Margo reported on the results of the Exhibitor Feedback Forms from the November event. Comments were generally favorable, but we may want to look at moving the event back to the first weekend in December. From the door prize entry forms, people reported that they heard about the EXPO primarily from road signs, Facebook, and friends.

Sandy suggested that we do “Exhibitor Spotlights” in the weeks preceding the event – highlighting the vendors who will be participating.

LIGHT UP TRENTON – Dena Abell, Jane Dixon, Kathleen Reed

This year’s judges were Jayne Jarrett James and Bonnie Cayce. The Grand Prize winner for 2022 is Trenton Mercantile – owner Carla Hall and artistic designers Vicki Atchley and Linda Wooten. They were presented with the traveling plaque at a ceremony in front of the store on 12/13. The committee will be visiting all the businesses who participated in the event and presenting them with the 2022 ornament.

TOURISM – Charity Barton

Charity reported that Sandy has requested that the Alliance include advertising in two publications: the Georgia State Parks digital guide and Discover Georgia Outdoors Travel Guide. She will need to place the ad in December to be included for the year.

OLD BUSINESS

Detail on expenses for office space for Sandy White. Marcy reported that a total of \$3,077 plus the cost of the security cameras was spent setting up Sandy’s office. That fell below the \$3,500 approved by the board at the October meeting.

401K and Health Insurance. Marcy reported that the 401K Plan documents have been signed and both Sandy and Margo will be enrolled in January 2023.

Margo will continue medical coverage under her parents’ plan. The Alliance has set up a Health Reimbursement Account to reimburse Sandy for her health insurance – up to \$600 per month. Using the HRA will provide both Sandy and the Alliance with tax savings.

NEW BUSINESS

Board appointments. Stacey made a motion to approve the appointment of William Back and Carey Fauscett-Anderson to the board. Jane seconded the motion, and all board directors present approved. Their three-year terms will officially begin in January, 2023.

Charity moved that Jane Dixon, George Williams, and Marcy Williams be re-appointed for another three-year term on the board. Dorinda seconded the motion, and all board directors present approved.

Officer Elections. Marcy reminded the board that we will vote to elect officers at the January board meeting. Anyone wishing to nominate themselves or someone else for the positions of Chair, Vice-Chair, Secretary, or Treasurer must submit the nomination to the board secretary no later than December 27, 2022. The secretary will notify the board of all nominations on December 28th. Nominees will have an opportunity to address the board before the election at the meeting in January.

Proposed 2023 Budget. Marcy distributed copies of the proposed budget for 2023 and explained how expenses are classified. Directors should address any questions they may have to Sandy White. The board will vote on the budget at the January board meeting.

DCHS banner for baseball field. Marcy moved that the Alliance pay \$200 in year one, and \$150 in subsequent years to display a banner at Dade County High School. Stacey seconded the motion, and all board directors present approved.

It was suggested that we also inquire about the cost to display a banner at the Dade County Sports Complex and Marcy agreed to find out about the cost.

At this point in the meeting, Stacey moved that the board move into Executive Session. Jane seconded the motion, and all board directors present approved. Sandy White and Margo McDade left the meeting. William Back and Carey Fauscett-Anderson were invited to stay.

Kathleen Reed moved to return to the regular meeting, Jane Dixon seconded, and all board directors present approved.

Kathleen Reed moved that Margo McDade receive an increase at the annual rate of 3% effective the first payroll period of January 2023. Charity Barton seconded the motion, and all board directors present approved.

Marcy Williams moved that the Alliance provide both Sandy White and Margo McDade with a holiday bonus of \$250 in cash. Kathleen Reed seconded the motion, and all board directors present approved.
