ALLIANCE FOR DADE BOARD MEETING SEPTEMBER 12, 2023

Investor Report As of 9/12/23 - 127 current investors, with 7 renewals still unpaid. Discount Flooring, Talley Construction, Corner Coffee, Mostellar's Towing, Bank of Dade, Covenant College, & Peace Love Bling. New members since last report: ZA Brew Cold Brew Coffee, Silk by Claire, The Shop on Main & Dade Fabrication LLC. Last month's renewals are Dyer Beef, IDA, Josh & Andrea Cain & Trenton Pressing.
