ALLIANCE FOR DADE BOARD MEETING NOVEMBER 28, 2023

Investor Report As of 11/28/23 - 134 current investors. Talley Construction, Corner Coffee, Mostellar's Towing, Covenant College, & Peace Love Bling are late. New members since last report: Trenton Family Dentistry, Thierry Flamant. Since last report renewals are Blooms & Stitches, Lawson Medical, and Dade County Farm Bureau.

- 1. Welcome Center Visitors in October (local 39, visitors 97, phone calls 25).
- 2. Our Southern Living Ad which came out in October has received over 700 leads from the reader response card. These potential visitors have requested additional information and have been sent our new visitor guide. Our ads are now out in the Cloudland Canyon State Park map, the Holiday Travel Park map in Chattanooga & the Battlefield Campground RV Park map in Ringgold. We have just places an ad in the Trenton Golf Club Course Guide, this ad will be in the guide for 2 years as will get in the hands of approximately 100,000 golfers.
- 3. Facebook numbers: Reach for last 90 days 45,500. We are up to 1161 followers and 777-page likes. We are at 161 for Instagram followers with a reach of 1800 in the last 30 days. Trish has also been twitting events on twitter, so we now have 38 followers on Twitter.
