**Workforce Development Committee:** Hans Pfunder hosted the official meeting on October 22, 2024 at 6p at Trenton Pressing.

Alliance for Dade (AFD) Workforce Development (WFD) will offer forklift operation training. The class will be offered at Trenton Pressing by AFD. Start date and cost of training to be determined (TBD), training frequency will be every other month. Hans discussed at the meeting about starting a career center here in Dade County to match up the people looking for a job with businesses needing workers in the first stage. Start small and eventually have an independent building to have a place for classes and onsite training, professional environment, internships. It was also discussed in the WFD meeting to start a central hub to offer soft skill training for people to advance in their current job. Hopefully this will attract new and different businesses to Dade County. This is a scalable project. Sandy White said that Don Townsend said Commissioner Hartline failed to remember when the renovation started and it would not come out of general funds. AFD is the official DMO for the County and per State Law, the official DMO and Welcome Center has to be in this building in order for the County to use hotel/motel funds for its maintenance and operation.

Jane asked if anyone else would be paying rent. Sandy answered - IDA will pay rent, but historic preservation commission will not due to the fact they are a county authority.




