CALL TO ORDER AND ROUTINE MOTIONS				
Call to Order	By George Williams at 6:02 PM

COMMITTEE REPORTS

Provided to all Directors in advance and attached to these minutes. The following questions raised in the reports were discussed:

<u>Finance</u>. Discussion regarding how income/expenses are being entered and reconciled. Harry, Christina, Kathleen and Marcy will meet to work out procedures.

<u>Tourism</u>. George asked Charity to clarify what she meant by "branding" in her report. Charity said the committee feels we need a "hashtag/tagline" to identify Dade County – similar to "Walker Rocks" or "Chattooga Rolls" – to be used on social media and printed materials. They will reach out to Carey Anderson at the county to see what may already be in the works.

OLD BUSINESS

<u>Tourism Map</u>. Charity Barton reported about the meeting she and Marcy Williams had with Todd Smith from ExploreChatt. He would like to help us produce a map highlighting the attractions in Dade County (and nearby areas). With our input, Todd will identify the attractions to include, sell advertising to businesses to appear on the map, design and print the map, distribute the maps to hotels/campgrounds/rental properties, and store any excess. Todd can get this done by Memorial Day. Charity and Marcy do not believe the advertising sales will fully cover the cost of production and may ask the Alliance to contribute to the expense or find a sponsor to help cover the expense. The tourism committee will have more information by the next board meeting.

NEW BUSINESS

<u>Blessing Box</u>. Kathleen Reed recommended that we add a plaque to the Blessing Box to honor Alan Bradford, who was instrumental in helping us with the location of the box. Suggested wording:

This Blessing Box is dedicated to the memory of Alan Bradford (date – date) A man whose kindness and deep compassion was felt by the community he loved His servant's heart will never be forgotten.

Marcy will help with designing and ordering the plaque to fit the box. Once the box is installed at the corner of Sunset and Hwy 136 sometime next week, then we will decide how to best position the signage. Kathleen also talked about holding an event to dedicate the box, to include county officials, family, pastor, and Alliance members. Once all the signage is installed, then we will plan the dedication.

Alliance Response to Media or Individuals.

George said that from time to time, the Alliance receives requests for comment from media or investors or the public. He asked that any such inquiries be directed to Jane Dixon, Publicity Chair, or to himself to provide an official Alliance response.

Alliance representatives to local organizations.

The Alliance should be represented at other county organizations such as Dade First Family Connection, THACC, Lookout Mountain Parkway Association, etc. George asked the board directors to help identify those organizations and which they would be willing to attend. Email that information to George and we'll discuss again at the May board meeting.

Pro-rating Investor fees.

Currently, those joining the Alliance are invested through December 31, 2021. As we are into the second quarter of the year, the board discussed whether Investor fees should be pro-rated for investors joining now. Or, should we look at setting up a system that will allow us to invoice Investors on rolling anniversary dates throughout the year? George asked Kathleen to investigate how other chambers of commerce in our area are handling this. It is easier to invoice everyone at once at the start of each year but Christina Thoreson suggested that rolling payments would help our cash flow and provide an opportunity for the Alliance to recognize investors on their anniversary date. The board will decide at the May board meeting.

Uncle Lars Spring Fling.

Dena Abell presented a request from Shannon Blom at Uncle Lars for the Alliance to have a booth at a 2-day event with businesses, arts, crafts, and non-profits displaying their work. Dena moved that the Alliance pay \$40 to set up a booth at the Spring Fling. Harry seconded.

After discussion, the board decided that rather than having a booth, the Alliance should 1) attend the event and walk around to visit the participating businesses to encourage them to join the Alliance, and 2) offer to help Shannon with clean-up at the end of the event.

Shannon let Dena know that she could use help with 1) parking lot attendant, 2) sanitation crew, 3) greeter to hand out maps/ballots/bingo cards. Charity agreed to set up a chart with time slots for Alliance directors to volunteer.

US 11 Antique Alley.

Marcy Williams reported that the Alliance has been asked to administer this event, which occurs on the weekend after Mother's Day. It brings thousands of visitors to Dade County, as we are about mid-point on the route from Meridian, MS to Bristol, VA. The board agreed that, although we would not be able to do much this year, we should definitely agree to support this event in 2022. One thing we need to look at this year is that Hwy 11 will be closed for construction south of Trenton. Should we look at doing a banner to display on the highway indicating the food and amenities available in Trenton and how to get there?

Jane Dixon moved that the Alliance should agree to administer this event. Charity seconded, and all board directors present approved.

April Awareness.

Jane challenged each board director to increase awareness of the Alliance in our community. Charity mentioned that we need to use social media more to get the word out. Kathleen suggested that we form a Social Media Committee, but the board agreed that we really need one point person to provide a consistent "voice" for the Alliance. At this point, we don't have a candidate for this role. George reported that the *Alliance Live!* videos will be ready soon and release one per week on our website, on the county website, and on KWN-TV. George asked each board director to bring in one new member by the end of April, understanding that many in the community are still leery about joining. He is proud of each of the board and committee volunteers and the job they all are doing until we can hire an Alliance President.

OPEN FLOOR

Kathleen Reed reported that our landlord, Robin Rogers, is re-evaluating our rental agreement. The Alliance currently pays \$250 per month, half the normal rent for our Welcome Center space. Rogers was considering raising it to \$400 per month but agreed to hold at \$250 for one more year. We need to be aware that this expense will increase in future.

FINANCE – Harry Abell

IRS form 990-N (annual filing) for Alliance for Dade Inc. was filed but reject by the IRS (normally due by May 15, 2021 – extended to November 2021). I contacted the IRS and they made some adjustments and their master database needs to be updated and that can take 6 weeks or so. I am working on issues with the 2020 Federal tax filings and we are due a refund of \$15.19 for unemployment tax. This can take up to 4 weeks. The Georgia Department of Revenue will issue a refund of \$59.55 - no notice on when this may be received.

I am investigating if Gusto (our payroll service) paid the IRS the correct amount for 2020.

I received two letters from two different IRS locations on the same day with different addresses for us. I confirmed the one below is the official one currently associated with our EIN.

We have had a number of new investors join the Alliance and also received the February DMO & RVIC checks.

A table at the Sheriffs Benefit Auction was purchased for half price (an anonymous person paid half). The table of 8 was filled with Alliance volunteers and with our employee Titus. The payment for those seats was paid by check to the Alliance for Dade (total of \$200). I wrote a check for \$200 to the Dade County Sheriffs Organization (DCSO).

WEBSITE – Harry Abell

There were several issues with plug-in conflicts on our website. I worked with the provider of the plugin causing the issues and they have made corrections. I have disabled this plugin until I have time and energy to deal with this. We have not been using that set of plugins and it was intended to replace the set of plugins we use from Chamber Dashboard.

MEMBERSHIP – Kathleen Reed

Since I have been helping to handle my Father In Laws estate and traveling out of town to accomplish that I have not been able to focus on Membership. I have personally contacted businesses encouraging them to join. Very positive response. I look forward to them joining the Alliance very soon.

I encourage each Board Member to always be on the lookout for new Investors to add to our Investment Base. Next month I plan on meeting with a successful campaign manager to develop a Membership growth plan.

Prorating Investment joining fees and a letter with attachments for potential investors will be covered under New Business.

PUBLICITY – Jane Dixon

This past month the awareness of the Alliance for Dade has reached the public in a variety of ways. Dena Abell's took the lead with the Blessing Box Project and more to come from her this month. Dena Abell spoke at the Optimist Club meeting discussing the Alliance support of a Blessing Box on Lookout Mt.

New investors are joining as board members continue to talk with prospective investors. Titus and Marcy have been making contacts by email with previous chamber members.

Alex Case invited us to join in with the Grand Opening of Tractor Supply and the Alliance hosted the Ribbon Cutting. The Sentinel and Evan Stone covered this event, and many folks came out to celebrate. George Williams has been working with Evan Stone to bring to life the concept of The Alliance Live. This will promote the Alliance Investors on television and Discover Dade.

We continue to report to both the City and County Commission with monthly updates.

In support of Blue Day, with Families First, we distributed flyers to businesses requesting their support.

Our website continually powers to put the Alliance name in a positive role, working for the community. The more the Alliance representatives can be seen and heard - the more we will grow and meet our mission. We continue to secure more investors because of our efforts to keep a high profile and invite folks to become an Alliance investor! Look forward to "April Awareness".

BUSINESS SERVICES – George Williams

Alliance Live! is the current focus of the Business Services Committee. I have completed 3 recorded videos with Rose Powell at the Tri State Food Pantry, Steve LaPlante at Integer, and Will Garrett at Guthrie's. This week I plan on interviewing George Reed at Trenton Physical Therapy and Ted Rumley, Dade Executive. Many thanks to Evan Stone for providing the recording equipment and his time to attend the first 3 interviews. We will begin putting the recordings on social media late this week or early next week.

Business Services assisted with the grand opening ribbon cutting of Tractor Supply and will do a ribbon cutting at Dollar General on Smith Road Friday morning April 9.

WELCOME CENTER & SIGNAGE – Marcy Williams

Dade County/City of Trenton maps are now available at the Welcome Center! Charity Barton (Tourism Committee Chair) and Marcy are meeting with Todd Smith from Explore! on Tuesday, April 6 to look at the possibility of using his company to help us develop a "tourist attraction" map that will include advertising and coupons.

Nelson Eash provided the 3 spots where he installed Welcome Center signs. A fourth sign is being held at the Welcome Center. I have identified 8-10 locations for signs and will start investigating suppliers and pricing for larger signs.




The members of the committee were sent a survey about our committees goals this year. Of the responses our goals for the coming year were to create a social media campaign and brand for our community.

Butch is asking the Alliance to become the "administrator" for the US 11 Antique Alley organization

Route stretches from Meridian, MS to Bristol, VA - Dade County is in the middle Butch estimates that the event brings 5 - 8,000 people per day to Dade County Opportunity for Alliance to promote tourism and economic development in Dade

As administrator, Alliance would:

- Maintain current information for "partners" along the route chambers, CVBs (~50)
- Contact partners on an annual basis (4th quarter) to get updated information about the food, lodging, gas stations, special events in their area
- Post the information on the website and invoice each partner a \$100 administrative fee
- Update the website http://us11antiquealley.com/
- Partners can charge businesses in their area \$25 for an "ad" info about special event, info about vendor spaces for rent, etc.

For Dade County, Alliance would/could:

- Promote US 11 Antique Alley put on Alliance website, buy print ads, social media, buy TV spots on KWN TV, purchase Festival site ads, free TV appearances, etc.
