CALL TO ORDER AND ROUTINE MOTIONS

COMMITTEE REPORTS

Committee reports were provided to all board directors prior to the meeting and are attached to these minutes.

DADE EXPO – Jolly Holidays! Harry reported that we are in great shape for the event this Saturday. The committee agreed to simplify by renting tables, as opposed to borrowing them from multiple organizations. Harry reminded those in charge of signs to be good citizens and pick them up right away on the day after the event.

Light Up Trenton. Dena, Jane, and Kathleen reported that they posted signs and banners around town. All participating businesses will receive an ornament in the shape of Georgia with the LUT lamppost artwork (40 were purchased at ~\$3 each). Two local people will judge business light displays to determine the 1st place winner. Citizen's Bank & Trust, the 2020 winner, will pass the plaque to the new winner on KWN-TV morning show on Wednesday, 12/8 and also on the county FB Live update on Thursday, 12/9.

Tourism. Charity reported that she has met with Todd Smith, and he is putting an attraction map together. Todd is requesting a letter from the Alliance to introduce him to potential advertisers. He has also asked if the Alliance is willing to contribute part of the cost for the maps. The board agreed to move forward with this project but would like a firmer idea of the cost before fully committing. Stacey suggested that Charity contact David Jackson, the Marion County executive, to get his feedback on the work that Todd did for the tourist map there.

OLD BUSINESS

Governor's Mansion Ornaments. The Alliance will purchase the Train Depot and the Historic Courthouse pewter ornaments from the Friends of the Library and send them to the Governor's mansion for display. Rebecca Hazen from The Dade Sentinel will interview and take a photo of representatives from the Alliance and from the Friends of the Library to write an article for the paper.

Christmas Parade. Kathleen is still firming up the plan to display Alliance for Dade signage on the Mustang Club cars.

NEW BUSINESS

Christmas Cards to Investors. Marcy reminded the board that we sent Christmas cards to all investors last year and suggested that we do so again. She showed an example of a card and estimated that the cost would be ~\$225 for cards and postage. Harry moved, and Stacey seconded, that the board approve an expenditure of up to \$250 for the cards. All board directors approved.

Welcome Center window decal. George Williams recommended that we remove the old Dade County Chamber of Commerce decal that is still on the Welcome Center door and replace it with an Alliance logo and the words "Your Chamber of Commerce and Welcome Center." Kathleen moved, and Jane seconded, that the board approve up to \$200 for a new decal. All board directors approved.

Office Equipment for Welcome Center. George shared that it is very difficult to hear callers on the phone in the Welcome Center. In addition, the computer keyboard needs to be replaced. TVN supplied the VOIP phone, so we will call them and ask for a replacement. Harry said he has a used keyboard that he will donate to the Welcome Center.

Appointment of Board Directors. Four nominees to serve a three-year term, 2022-2024, were presented at the November 2 board meeting. Marcy moved, and Charity seconded, that Harry Abell, Dena Abell, Kathleen Reed, and John Rollins be appointed to the board. All board directors present approved.

Officer Nominations for 2022. The secretary reported that the following people has submitted their names for consideration for an officer position. Each of them made a short presentation about their qualifications and why they would like to serve.

Vice Chair John Rollins agreed to continue in the position if no one else was interested. The board discussed the possibility of having co-Vice Chairs and asked other board directors to consider the position. Jane moved, and Harry seconded, that the board table consideration of the Vice Chair role until the next meeting.

The Board will appoint Officers at the next Board Meeting.

Board Orientation. Marcy recommended that we schedule a board orientation session to review board policies and role responsibilities. William Back offered to present information about board ethics and open meetings rules. Marcy moved, and Kathleen seconded, that we schedule a separate meeting sometime in January for the orientation. All board directors approved.

OPEN FLOOR

Jane challenged each board director to bring in one new investor before the end of the year to help us reach our goal of 100 investors by the end of 2021. She will distribute Investor Applications to exhibitors at the DADE EXPO.

Marcy reported we will be distributing Investor renewals in December. Marcy moved, and Jane seconded, that we add two new levels - \$2,500 Diamond and \$5,000 Platinum. All board directors approved. Dena suggested that we write a summary of the Alliance's accomplishments in the past year to go out with the renewal notice. George and Marcy will write the letter and encourage investors to "step up" their investment level.

Orey Yates reported that the Mountain Valley Independent online newspaper has a monthly readership of 90,000. He can include a weekly update of Alliance activities. Jane agreed to write a weekly article.

Orey will include an article about the newly appointed board directors.

Orey asked for permission to "rebuild" our Facebook page to better suit it for a non-profit organization. The board encouraged him to do whatever is necessary. Orey reported that the best way to contact him is via text at 423.779.7774.

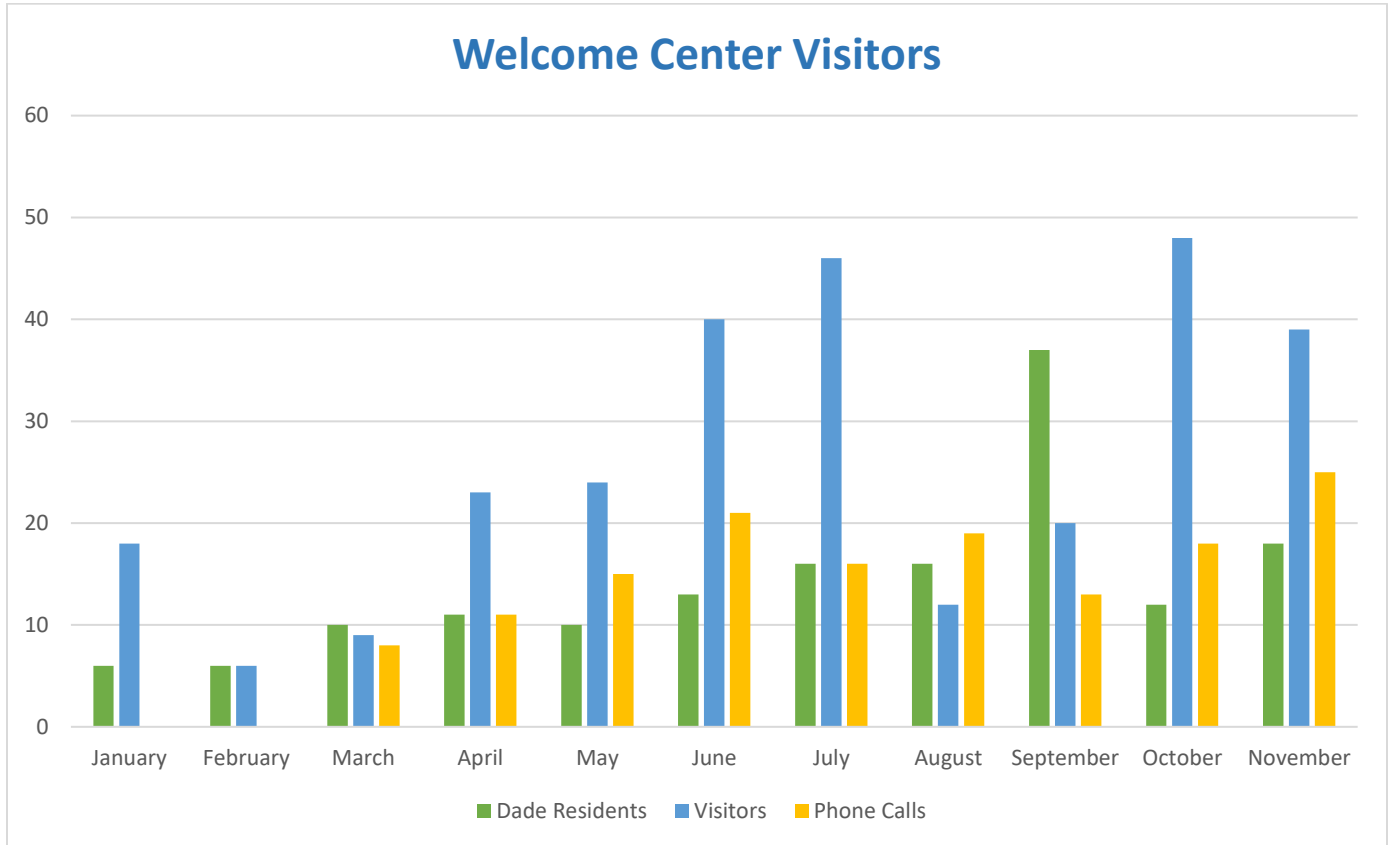
At 7:45, Harry moved, and Kathleen seconded, that the board adjourn for executive session to discuss a personnel issue. All board directors approved.
