February 8 - Retreat scheduled with Tamara Brock with GA Power Sandy to give update on strategic plan from 2023 Strongly suggest to have a yearly planning session

Sandy presenting - Funding for Library - Tourism promotion funding - 18 signs for the story walk - along trail behind Citizens bank - permanent installation and a nice tourist attraction. \$2500 is being requested by the library for tourism funding - Library has been working with the City and County and will talk to the bank.

George asks to make a motion to accept that we pay \$2500 to the Dade County Public Library - William makes the motion

Marcy Seconded the motion.

Dena questioned about the upkeep of the trail - who will be responsible for the upkeep of the trail. Library will upkeep the story walk stations. Dena and Heath still had concerns about the maintenance of the trail. Carey said that according to Monda the situation was resolved and city workers were maintaining it. Carey suggests that the story walk go around Jenkins Park and not Town Creek trail. AFD can promote the story walk.

William Back Amends the motion to support the grant for the story walk for the library to have 18 signs that will start East and go into and around Jenkins Park. Will only give money if it goes to Jenkins Park. Dena 2nds

All approved no opposed as long as it goes around Jenkins Park.

Saving Shaylia - Fundraiser on 2-3-24 requesting funding for advertising flyers in papers for the event - \$1,000. William provided additional input that Saving Shaylia isn't a tax exempt organization but Smoke on the Square is.

Made a motion to accept funding for \$1,000 for Saving Shaylia

Carey Fauscett-Anderson made a motion

Heath Cloud seconded it.

Vote - All opposed.

Follow up discussion regarding ByLaws - William Back

Make AFD ByLaws more flexible

Article 3

William makes a motion: Add a new paragraph 7 article 3 - Majority vote - to make minor deviations/provisions - put verbiage to this and bring to the next meeting in February to approve.

NEW BUSINESS

Nomination of Directors - William Back

Didn't have a December meeting so we didn't have nominations in December per the bylaws. Suggests to make nominations tonight 1-9-24 and vote in February elect directors and nominate officers and push off the officer voting to March. March vote on officers - Chair and Vice Chair have to be board of directors but Secretary and Treasurer doesn't.

Marcy suggests that new nominees for new directors should be present in the meeting for current Directors to meet and see how they fit with the existing group.

Carey suggests working/partnering with GNTC or SLTC or Covenant and see if they would match our scholarship effort

George will do more research and bring it back to the Board at the February meeting.
